**HIGH COURT MISCELLANEOUS CRIMINAL APPLICATION No. 685 OF 2010**  
**THE KENYAN SECTION OF THE INTERNATIONAL COMMISSION OF JURISTS -**  
**versus- THE ATTORNEY GENERAL & THE MINISTER OF STATE FOR PROVINCIAL**  
**ADMINISTRATION AND INTERNAL SECURITY**

As you are most probably aware, the Honourable Mr. Justice Nicholas Ombija ordered on 28<sup>th</sup> November 2011 that a Provisional Warrant of Arrest be issued against President Omar al Bashir of the Sudan pursuant to Section 32(1) of the International Crimes Act, upon the application of the Kenyan Section of the International Commission of Jurists (ICJ-Kenya).

This is to notify you, in accordance with the provisions of Section 33(1) of the International Crimes Act, that the Provisional Warrant has now been formally issued and sealed by the High Court, commanding you to apprehend President al Bashir should he come to Kenya. Copies of the two Warrants issued by the International Criminal Court, the Provisional Warrant by the High Court, and other documentary evidence that ICJ-Kenya produced to the Judge at the time of making the application are also enclosed, in compliance with Section 33(2) of the Act. The original Provisional Warrant may be obtained from the Deputy Registrar of the Criminal Division of the High Court, Nairobi, at the address below.
